Cres, Croatia, 31. 05 – 05. 06. 2016.



Notice of Race



1. Organizing Authority

Cres Sailing Week 2016 is organized by the JK Jedro, Rijeka (Sailing Club of Rijeka, SCOR) in conjunction with Udruga "Vjetar", Sailing Club "Reful", Cres under the authority of Croatian Sailing Federation and overall authority of the Offshore Racing Congress (ORC) and the International Sailing Federation (ISAF).

2. Rules

- 2.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 2.2 The following rules will also apply:
 - a) International Measurement System IMS
 - b) ORC International rating system
 - c) Offshore Special Regulations for Category 3
- 2.3 If there is a conflict between languages the English text will take precedence.

3. Advertising

ISAF Advertising Code will apply. Competitors & boats advertising will be without restriction. Event Advertising by the organizing authority will be:

- a) Bow numbers with advertisement which have to be displayed as forward as possible on the both sides of the first 20% of the hull
- b) Advertisement to be displayed on the both sides of the foremost 20% of the mainsail boom
- c) Sponsor's flag that has to be flown on the backstay throughout whole event

The Organizing Authority may also require the installation, at no cost to competitors, onboard video cameras, or global position devices.

4. Eligibility

Competitors shall comply with ISAF Eligibility Code. The regatta is open to all boats with valid ORC International certificate with GPH < 700 s/NM. All sailors shall be verified at their national sailing authorities.

In case of larger number of entries boats will be divided in classes with separate results and separate starts. Rating limits to divide the fleet will be decided based on entries received by 1st May 2016.

5. Entries and entry fee

5.1 Entries should be submitted to the organiser with the copy of rating certificate before 24th May 2016 by on-line entry form or e-mail. Late entries may be accepted at organiser's discretion, but free moorings will not be guaranteed and higher entry fee will be charged.



5.2 The non-refundable entry fee is determined by the date of entry and entry fee receipt as follows:

5.3 A boat is considered Pre-registered if the following documents are received before 24th May 2016:

- Completed entry form
- Current ORC International certificate
- Entry fee payment confirmation

5.4 The organiser is not responsible for any costs incurred by the non-acceptance of a boat's registration.

6. Registration

6.1 Each owner or skipper must personally register in the Race Office in ACI Marina Cres from 10:00 on Tuesday, 31st May 2016 until 19:00 on Wednesday, 1st June 2016.

6.2 The following documents shall be presented at registration:

- Valid ORC International certificate issued before 31st May 2016
- Valid third party insurance
- If advertising is displayed, a respective National Authority permission
- Crew list with name and sailing license number
- Contact phone both on boat and land, including the name of contact person
- Liability acceptance form, duly filled out and signed

6.3 No changes shall be made on ORC certificates after 31st May 2016 unless prescribed by the Measurement Committee Jury's approval.

6.4 Measurement protests by the boats shall be accepted up to two hours after the posting of the final ratings.

6.5 Crew lists may be amended up to 19:00 on Wednesday, 1st June 2016 by filling a new form showing the changes. After this time, changes in crew may be made only with the written permission of the Jury.





7. Schedule

Organizer may change the schedule.

7.2 Seven races are scheduled including one offshore race and six inshore races. Inshore races will be windward/leeward races.

7.3 The championship is valid if at least 3 inshore races and the offshore race are completed. One discard will be allowed if 5 races are completed, but the offshore race shall not be discarded.

8. Measurement

All boats shall be available for the inspection from Tuesday, 31st May at 10:00 until Wednesday, 1st June at 18:00.

9. Sailing Instructions

Sailing Instructions will be available for each entrant at completion of the registration formalities.

10. Nautical charts

The following nautical charts of the Hydrographic Institute of the Republic of Croatia are utilised as reference in the Sailing Instructions: 300-31, 100-16, 100-17, 100-18, 100-19.

11. Moorings

Organiser will provide moorings free of charge for all boats entering Cres Sailing Week in ACI Marina Cres from Monday, 30th May 2016 till Monday, 6th June 2016. If number of entered boats is greater than number of available moorings in ACI Marina Cres, additional free moorings will be provided in port of Cres.

12. Registration of arrival in Croatia

All foreign participants of Cres Sailing Week are excused of payment of tax for the registration of arrival and stay of foreign yacht or boat in territorial sea and coastal waters of the Republic of Croatia from 26th May till 10th June 2016. All foreign boats shall register at first custom office when entering Croatian territorial sea.

13. Media rights

Competitors, owners and their guests give absolute right and permission to the Organising Authority for any photography and video footage taken of persons and boats during the event, to be published and/or broadcast in any media, including but not limited to TV advertisements, whatsoever for either editorial or advertising purposes or to be used in press information.





14. Prizes

Trophies will be awarded in each class to:

- the best three boats
- the winner of the offshore race



Organiser may also give additional prizes.

15. Disclaimer of Liability

All those taking part in the regatta do so at their own risk and responsibility. The organising authority, SCOR, ORC, CSF and any other party involved in the organisation of the Cres Sailing Week disclaim any and all responsibility whatsoever for loss, damage injury or inconvenience that might occur to persons and materials, both ashore and at sea as a consequence of participation in the event. Each boat owner or his representative accepts these terms by signing entry form. The attention of competitors is drawn to ISAF Part 1 Fundamental Rule 4: A boat is solely responsible for deciding whether or not to start or to continue racing.
